

U.S. sportswear traced to factory in China's internment camps

WRC INVESTIGATION: SUMMARY OF FINDINGS

- FORCED LABOR: Badger Sport produced apparel in a factory in Western China's Xinjiang Province by workers who are detainees in a 'reeducation' internment center.
- FAILURE TO DISCLOSE: Badger Sport failed to include Hetian Taida Apparel among the facilities disclosed by Badger to universities for production of collegiate licensed apparel.
- FAILURE TO COOPERATE: While providing some information requested by the WRC, Badger Sport and factory owner declined to provide other information, including documentary evidence that would have shed light on labor practices at Hetian Taida and on Badger Sport's knowledge thereof.






Nearly Half of Uyghurs in Xinjiang's Hotan Targeted For Re-Education Camps




Young Uyghur men drive a car through a night market in Hotan, in China's Xinjiang region, April 15, 2015.

WRC INVESTIGATION: POSSIBLE VIOLATION

• FORCED LABOR IN SECOND FACILITY: There is a possibility that forced labor was also utilized in the facility Hetian Taida relocated to, specifically that former detainees of the HVETC were, after their release, forced by the government to work at this facility. There is insufficient evidence available to reach a definitive conclusion as to whether this did or did not occur.
