An overview of the WRC's work around the world over the last year, covering new cases and projects, and providing updates on ongoing work. Topics will include: Gildan (Dominican Republic), Shahi Exports (India), implementation of the Nike and Russell Accords, implementation of minimum wage remediation in India, the persecution of labor rights advocates in Bangladesh, the Designated Suppliers Program and supply chain reform, and updates on Alta Gracia Apparel, including an overview of the forthcoming results of a major academic study of the impact of living wage on workers and their families.

Fire Safety in the Apparel Industry, 100 Years After the Triangle Shirtwaist Fire -- and the Implications for the College Market

An analysis of the worker safety crisis that confronts the apparel industry, particularly in Bangladesh and India. We will discuss recent fatal fires, their causes, the implications for the 150-plus university licensees sourcing from the region, and ongoing efforts to bring about reform. The discussion will be prefaced by a presentation on the Triangle Shirtwaist fire, which occurred on March 25, 1911, and the role of that fire in spurring workplace reform in the United States.

Contending with Company Unions: How Management-Controlled Worker Bodies are Used to Thwart Associational Rights, and Effective Strategies for Remediation

A review of one of the toughest issues facing labor rights monitors: the use of company unions to block associational rights. The discussion will cover the various forms of company-controlled and influenced unions, citing specific cases at collegiate factories, and will emphasize how labor rights monitors can most effectively tackle this growing problem. We will have a presentation from a former apparel worker and current union organizer in the Dominican Republic who will discuss his direct experience in the Gildan case.
